DCN Workgroups

The Driving Change Network have a number of workgroups who get together on a monthly basis to discuss issues and problems that they may have relating to a particular area of the driving training and licensing space.

Examples of the types of issues we work together on are our **Multicultural Group** - who look at driver licensing issues affecting migrants and refugees, such as distance to sites able to do overseas licence conversions, access to interpreters and how COVID has affected students who require an interpreter to travel in the vehicle for tests with them.

Our **Best Practise Training** workgroup are currently working on two projects aimed to lift the standard of community driving programmes around the country while supporting programmes experiencing difficulty or just getting started in the space.

These groups meet monthly for no more than an hour. They both aim to provide support for our members and to improve road safety in New Zealand.

We need more people to get involved in these groups. A full list of these are included on the front page of this newsletter. There is no commitment to attend every meeting, just when you can.

Request for driver licensing to be classified an essential service




Many of you will have been affected by government mandates when the NZ COVID traffic light system came into play.

While driving educators being classified as close contact businesses and the requirement for learners to be fully vaccinated came as no surprise, the fact that many of our students would be prevented from sitting their practical license test did. Check out this News Story

After a number of media stories and correspondence and meetings with MP's and government officials, we are confident that driver licensing will soon be reclassified as an essential service.

Online catch ups December 2021



At the end of last year, thanks to COVID, our normal tour of New Zealand to catch up with community providers and driving educators was taken online.

During this meeting, members were asked to vote on which of the Driving Change Network priorities were most important to them. The chart above highlights the results.

These factors were used earlier this year when the Steering Committee gathered to finalise the 2022 plan for the year.



Updates from Waka Kotahi courtesy of our liaison.

- A small-scale review of the official New Zealand road codes are underway to meet a new printing order due in April 2022.
 This review is focussed on providing better consistency with the theory test questions and better clarification of expectations of road users.
- A review of all learner licence theory test questions is underway. Questions will be rephrased in plain English and images will be provided to assist understanding. These changes should be in place by mid-2022.
- Work is underway within Waka Kotahi to develop a five-year operational and delivery strategy for the future of the driver licensing system.
- Driver testing has been determined to be a close contact service, and to comply with guidelines of the new traffic light system, all test applicants must be fully vaccinated and show a 'My Vaccine Pass' to sit a test. If test applicants are joined by a support person, the support person must also show a Vaccine Pass. If a test can't be conducted, the applicant can choose to have it rescheduled free of charge to a time when it can be conducted safely in line with COVID protocols or obtain a refund from Waka Kotahi. - The effects of Covid-19 lockdowns during the second half of 2021 means driver testing is still experiencing increased wait
 times across the country, and especially so in Auckland, Northland, and the Waikato. Waka Kotahi is working closely with
 VTNZ to increase the number of tests available but this will take time. We understand that this may be frustrating for your
 clients and thank you for your patience.

BLUE LIGHT VENTURES - Youth Driver Navigator Programme

Blue Light's Youth Driver Navigator Programme empowers young people to access education and employment opportunities and achieve life- long success trajectories. By working with young people to tackle their barriers to licensing Blue Light ensures that youth can progress from no licence all the way to obtaining their full licence, while also learning how to be better, safer drivers.

Unfortunately not available to all young people, Blue Light's Youth Driver Navigator Programme seeks to support those who need it the most. Being accepted into a Blue Light Youth Driver Navigator Programme is dependent on being between 16 and 24, having limited or no access to a suitable vehicle, having limited or no access to a supervising adult, and having limited financial means to meet the cost obligations of attaining a licence.

Issues they help students address are financial barriers such as an inability to afford driving instruction or licence fees; time and

scheduling barriers such as having home and work obligations; a lack of adequate identification; a lack of access to a licensed supervising adult; a lack of access to an adequate car to practice in; poor literacy; and a family history of undervaluing the benefits of having a licence.

Many participants are driving outside of what their licence legally allows. Blue Light helps these people legitimise their driving to ensure that they do not unnecessarily engage with the justice system, which often compounds many of the issues that prevented them from obtaining a legal driving status in the first place. For many participants they will be the first member of their family to obtain a licence.

After two years in their current contract they proudly boost the following life changing successes

2265 Students 1831 Learner Licence Passes 863 Restricted Licence Passes 82 Defensive Driving Participants 107 Completed with Full Licence

A recent Good Measure Report of the programme was completed by Impact Lab and they concluded that some of the direct outcomes of participation in the Youth Driver Navigation Programme were:

- Improved self esteem and mental health
- Increased rate of driver licensing in youth
- Increased confidence
- Reduction in risky behaviours on the road

They also concluded that every year this programme delivers \$10,019,972 of measurable good to society, and for every dollar invested in this programme the Youth Driver Navigator programme delivers \$7.20 of measurable good to New Zealand.










Blue Light's Youth Driver Navigator Programme creates social value across different aspects of people's lives.


This chart shows the breakdown of social value created according to the Living Standards Framework. Each domain highlights a different aspect of wellbeing.
